Beginning Farmer Program Administrative Notes

FY 2012 – 2013 July 1, 2012 – June 30, 2013

The Beginning Farmer Tax Credit Act was passed by the Nebraska Legislature and enacted into law on August 28, 1999. The intent of the Act was to help beginning farmers and ranchers have access to agricultural assets by providing an incentive to a landlord who will enter into a three year lease with a beginning farmer. The incentive is a refundable Nebraska income tax credit.

Beginning Farmer Tax Credit Program participation continues to grow. Since the inception of the program, approximately 250 beginning farmers and ranchers have utilized the tax credit incentive to gain access to agricultural assets. Approximately \$5,600,000 in tax credits have been issued to landlords who have participated in the program. Past participants are reapplying to the program. Beginning farmers are growing their operations by adding additional farm ground with their current landlord or by leasing from a new landlord. Growing their operation is essential to beginning farmers and ranchers to secure a long term sustainable livelihood in farming.

Promoting the Beginning Farmer Tax Credit Program is a key focus of our staff. Our program administrator is a representative on several advisory councils providing services to the agricultural community. Outreach activities include agricultural farm shows, agricultural college and high school career fairs and farming and ranching workshops. Efforts are also made to educate service providers of farmers and ranchers. Service providers include bankers, tax preparers, accountants, cooperatives and extension agents. This year's outreach activities reached approximately 475,000 attendees. Husker Harvest Days, an annual farm show event featuring state of the art information and technology to today's agricultural producers, attracts approximately 100,000 attendees over the three day event. We experience our highest volume of potential program participants at Husker Harvest Days.

Legal Aid of Nebraska was awarded a three year Beginning Farmer and Rancher Development Grant. This grant provides a means to continue the network created under a grant awarded to Center for Rural Affairs which ended in 2013. Members include state and federal agencies, higher learning institutions, agricultural financial institutions and agricultural interest groups. The Beginning Farmer Tax Credit Program Administrator is a member of the network. The Legal Aid of Nebraska grant allowed for the hiring of a specialist to help beginning and retiring farmers and ranchers navigate the multitude of programs available to them. This specialist has been a valuable resource to our beginning farmer program applicants. She is a licensed attorney and her services are free of charge. She provides financial and business planning, expertise in legal contracts and succession and transition planning. Working together as a network and providing education and support regarding each other's programs provides a valuable resource to Nebraska's next generation of agriculture producers.

Other notes of interest regarding the program and Nebraska agriculture for this fiscal year were:

- The net worth threshold for applicants remains at \$200,000.
- Marian Beethe, Administrator for the Beginning Farmer Tax Credit Act Program was recognized by Governor Heineman as the Department of Agriculture's Administrator of the Year.
- Karla Bahm succeeds Marian Beethe as program administrator.
- One hundred percent of Nebraska's counties experienced extreme or exceptional drought conditions in 2012.
- Nebraska, Wyoming and South Dakota livestock producers experienced extensive cattle losses due to an October blizzard.




